- (2) The Vendors have agreed for the sale of the said property to the Minister for an estate in fee simple absolute in possession free from incumbrances at the price of Three hundred and Fifty pounds discharged from the said rentcharge.
- (3) The Rentchargees being satisfied that the other property comprised in the recited Conveyance will be a sufficient security for the said rentcharge have agreed to join in these presents in manner hereinafter appearing

NOW THIS DEED WITNESSETH as follows: -IN pursuance of the said agreement and in

consideration of the sum of Three hundred and Fifty pounds now paid by the Minister to the Vendors (the receipt of which sum the Vendors hereby acknowledge) the Vendors as trustees and with the approval and consent of the Rentchargees hereby convey and the Rentchargees as mortgagees and for the purposes only of testifying their consent to the exercise of the said trust for sale and of releasing the property hereinafte described from their said rentcharge hereby release unto the Minister ALL THOSE pieces or parcels of land in the parish of Llannon in the County of Carmarthen containing in the whole 43.497 acres or thereabouts as the same are more particularly described in the First Schedule hereto and are delineated on the plan hereunto annexed and thereon coloured green and blue TOGETHER WITH a right of way for the Minister for all purposes connected with the property hereby conveyed with or without vehicles and animals along the roads or tracks shown coloured brown on the said plan with power for the Minister from time to time should he so desire to make up the said roads or tracks to a width of Twelve feet to a standard suitable for heavy forestry haulage vehicles the Minister making good or paying compensation for all damage caused by him in the exercise of the rights here y granted EXCEPT AND RESERVING unto the Vendors and their successors in title owners and occupiers for the time being of the adjoining property now retained by the Vendors and capable of being thereby benefited a right of way for all purposes with or without vehicles over and along the road or track shown coloured blue on the said plan TO HOLD unto the Manister in fee simple discharged from the said yearly rentcharge of One hundred and Twenty pounds limited by the recited Conveyance and from all powers and remedies for securing the same


